Beeston Civic is working locally, together with the Council to create the List and is calling on members and locals within Attenborough, Beeston, Bramcote, Chilwell and Toton to get involved and nominate buildings, landscapes and gardens in our area.

Local listing essentially ensures that assets that are of local importance, but do not meet the criteria for being nationally listed or in Conservation Areas, are taken account of during the planning process should an application affect the building or site.

They help celebrate the breadth of the historic environment of a local area by encompassing the full range of heritage assets within it, and ensure the proper recording of local heritage assets.
